With 23 starters going to the line, Rocco put down a fine run with 2 finds and a back. With this win, "Rocco" will now be known as FC St. Clair's Prince Rocco Vulcano Leo, and is also halfway to his AFC title! Last we saw, Jon is still carrying a big smile!

Under the whistle of trainer/handler Bob Burchett and scout Valerie Weaver, **Wild Mtn Head Em Up-Move Em Out**, aka "Rowdy", garnered the blue amid nine starters at the St. Croix Valley Brittany Club Derby Stake in Rogers, Minnesota in mid-May. Eighteen month old Rowdy, owned by Marcy Beveridge and Roger Stowell with breeders/co-owners Helen and Brian Riggle, is dual pointed and will be furthering his training for adult stakes and stepping into the ring a bit this summer. Thumbs up to Rowdy and his team!

Roger Stowell's **Blazin Shadow's Bama Jama**, aka "Jammie", re-entered the field trial circuit this spring following a three year absence and an illness last year, and is showing all she's rarin' to go. Under the guidance of her trainer and handler Bob Burchett and scout Valerie Weaver, Jammie grabbed 3rd place in the Nebraska Brittany Club's OGD stake in April with 41 dogs going to the line. In May, with Bob on the whistle and amid 38 entries, Jammie took 2nd place in the Minnesota Brittany Club's OGD stake and grabbed her first two points toward an FC title. Both placements qualify her for the 2013 Gun Dog Nationals. Atta girl Jammie and team!
