Member Brags...

Roger Stowell's "Jammie" (Blazin Shadow's Bama Jama JH) continued to show her strength and enthusiasm through the fall 2014 season. With Trainer/Handler Bob Burchett on the whistle and under the watchful eye of Scout Valerie Burchett, Jammie kicked off her fall season taking second in the Missouri Valley Brittany Club's fall horseback trial's Open Gun Dog stake amid 34 starters. The next day, with her owner on the whistle and still ready to roll, Jammie thrilled her team by taking the blue in the 24 starter Missouri Valley Amateur Gun Dog stake. Returning to her home club trial in Thayer, lowa at September month end, Jammie and Roger grabbed fourth in the lowa Brittany Club Amateur Gun Stake with 16 dogs going to the line. Her 2014 placements made Jammie a National Qualifier for both the Open Gun Dog Nationals and the Amateur Gun Dog Nationals in Ionia, Michigan in October. Congrats to Jammie and her Team!! Atta Girl!

Four year old "Josey" (GCH Wild Mtn's Midnight Rendezvous JH), owned by Marcy Beveridge, put her team over the moon this fall. Traveling to the Branched Oak, Nebraska grounds to kick off her first trial of the fall circuit and under Trainer/Handler Bob Burchett and Scout Valerie Burchett, Josey took to the line amid 26 starters in the Nebraska Brittany Club Open Gun Dog stake and came home with the blue for a five point major. This proved to be an especially exciting win for Josey and her Team as it not only qualified her for the Open Gun Dog National Championship in Ionia, Michigan, but it sealed her Field Champion and Dual Champion titles. Josey will now be known as GCH/DC Wild Mtn's Midnight Rendezvous JH. Continuing on with Bob and Val, Josey returned to Branched Oak the very next weekend for the Missouri Valley Brittany Club trial and grabbed third place amid 34 starters in the Open Gun Dog stake. In her final trial of the fall season, with Roger Stowell on the whistle, Josey went to the line among 13 starters and took fourth place in the Greater St. Louis Brittany Club Amateur Gun Dog stake in Grove Spring, Missouri. Congrats to Josey and her entire Team...Great job!

Young "Rowdy" (Wild Mtn Head Em Up – Move Em Out), owned by IBC members Marcy Beveridge and Roger Stowell along with breeders Helen and Brian Riggle, followed his spring 2014 season that qualified him for the 2014 Open Gun Dog National Championship with a nice placement this fall. Returning to his home club trial in Thayer, Iowa, 2-1/2 year old Rowdy went to the line amid 22 starters at the Iowa Brittany Club's fall trial and grabbed fourth place in the Open Gun Dog stake. Atta boy Little Man!! Congrats Team Rowdy!

Jon St. Clair's "Rocco" (FC St. Clair's Prince Rocco Vulcano Leo), already qualified for the 2014 Amateur Gun Dog National Championship by virtue of grabbing 3rd place in the 2013 Amateur National Gun Dog Championship, put down some nice runs in some good sized stakes this past year. Rocco also qualified for the 2014 Open Gun Dog National Championship by grabbing 3rd place in the Iowa Brittany Club's spring Open Gun Dog stake amid 34 starters. Continuing on in his home state Roc then took 4th place with 33 starters going to the line in the Hawkeye Brittany Club's spring Open Gun Dog stake. The fall circuit found Rocco at the Southern Kansas Brittany Club's Open Gun Dog stake where among 35 starters, he garnered 4th place. Atta boy Rocco!...Congrats to your Team!
