The Iowa Brittany Club extends an invitation to you to attend the Spring 2018 Field Trial held at the Union County Ranch, two miles south and one mile west of Thayer, IA

This trial is licensed by the AKC and recognized by the *American Field* and Amateur Field Trial Clubs of America.

The one-hour gun dog/shooting dog stake is recognized by the *American Field* as the

IOWA BRITTANY SHOOTING DOG CHAMPIONSHIP (aka Ed Powell Memorial Classic)

Your dog does not have to be registered in the Field Dog Stud Book to compete, but only dogs with FDSB registrations will be recognized as Champion and Runner-Up. Similarly, only dogs with FDSB registrations in the remaining stakes will be recognized as having qualified to run in other AF Championships.

DIRECTIONS TO THE GROUNDS

From Interstate 35 N or S: Take Exit 33 at Osceola and turn left (west) onto US Hwy 34. Proceed approximately 13 miles to Thayer. Turn south on county Hwy P-64. Proceed 2 miles to 210th St (gravel road). Turn right (west) and go approximately 1-1/4 mile. The field trial grounds will be on your right.

From Interstate 80 W: Take Exit 86 and turn south onto State Hwy 25 to Creston. In Creston, turn left (east) at intersection with US Hwy 34 and proceed approximately 17 miles to Thayer. Follow directions given above.

USE OF ELECTRONIC DEVICES AT FIELD TRIALS:

Please be aware that AKC and American Field have become stricter about the use of electronic tracking collar receivers in field trials. The following sums up the current regulations imposed by AKC:

Carrying Receivers -- The scout may not carry a receiver. The handler may carry a receiver with the permission of the Judges. The receiver must be turned off while the dog is under judgment.

The following is reprinted from the American Field. Please note comments regarding cell phone usage.

Electronic Devices at Recognized Field Trials

Aug 24, 2015

The print issue of August 22 carried the feature pertaining to the Minimum Requirements and other matters pertinent to the proper conduct of recognized field trials. This addendum, or follow-up, addresses the use of electronic devices at recognized trials, specifically cell phones and retrieval collars.

First and foremost, the Field Dog Stud Book, in concert with the Amateur Field Trial Clubs of America, does not endorse or recommend use of any specific brand of collar. Use of the retrieval collar is to assist a handler in finding a dog that may be lost or which is deemed to be no longer in judgment.

There are a few rules for the use of such collars:

- No modifications are to be made to the collar other than a name tag may be added. The collar, one inch in width or less, must have a flat surface against a dog's neck (no protrusions).
- The collar's transmitter, battery and antenna placed on the dog shall weigh no more than nine (9) ounces. (Temporary exception for this season is the Garmin T5 which has a weight of 9.3 ozs.)
- If a handler elects to use a transmitter collar on his or her dog, only one other identification collar is permitted on the dog. The retrieval collar shall remain on the dog during the entire heat. If the handler elects to remove the collar, the dog shall be considered out of judgment.
- The hand-held locating receiver shall be kept in the possession of the judges and/or their designees while the dog is in judgment.
- The locating receiver is to be used only when the dog is determined to be out of judgment.
- The running of the stake shall not be held up due to lack of available equipment.
- Recovery units shall be turned off when in the judges' possession.
- Any person using a receiver to locate a dog currently in judgment and prior to official authorization of its use by one of the judges shall disqualify that dog in the stake and the offenders shall be disqualified from field trials.

Club officials and those judging recognized trials are to be conversant with these rules to ensure uniform practice in both open and amateur stakes.

Cell phones in the gallery is another matter. The ubiquitous cell phone is marvelous technology and a valuable asset in the gallery in the event of an emergency. But cell phones can serve as a distraction when in use or as a vehicle for inappropriate communication when dogs are competing. It is common practice at concerts, theatre presentations or religious services for cell phones to be silenced. And such also applies to field trials when dogs are competing. Use of cell phones while dogs are competing is prohibited and such devices are to be turned off or in a silent mode.

It is understood that on rare occasions a person attending a trial may be expecting a pressing or emergency call. The stake manager should be apprised of this and announce this circumstance to attendees. If the call is made, the recipient is to move away from the gallery to take the call.

While these imperatives are noted in black and white, there are other standards — notably fairness, sportsmanship and common sense — which also come into play to ensure the integrity of the game.
