## Directions to Hunt Test Grounds Van Polen Farms near Oskaloosa, Iowa

### From Oskaloosa

- Follow N Market Street / U.S. Hwy 63 south from Oskaloosa, merge onto US 63 south toward Ottumwa (6 miles)
- Turn right onto 310<sup>th</sup> Street / County Hwy G71 (7 miles)
- Turn left onto Elba Ave / County Hwy T73 (1.5 miles)
- Turn left onto 325<sup>th</sup> Street, proceed to grounds by Quonset hut on the right

### From Des Moines

- Follow SE 14<sup>th</sup> Street / U.S. Hwy 69 south from Des Moines
- Merge onto IA 5 south (19 miles)
- Turn left (east) onto Hwy 92 (10.6 miles)
- Take IA 5 South (exit 60) toward Albia/Knoxville, turn right (south) on Hwy 5
- Turn left (east) on County Hwy G71, about 5 miles to Bussey, follow G71 through town, then 6 miles to Elba Ave
- Turn right onto Elba Ave / County Hwy T37 (1.5 miles)
- Turn left onto 325<sup>th</sup> Street, proceed to grounds by Quonset hut on the right
