### ***IOWA BRITTANY SHOOTING DOG CHAMPIONSHIP (aka Ed Powell Memorial Classic)***

Your dog does not have to be registered in the Field Dog Stud Book to compete, but only dogs with FDSB registrations will be recognized as Champion and Runner-Up. Similarly, only dogs with FDSB registrations in the remaining stakes will be recognized as having qualified to run in other AF Championships.

#### **DIRECTIONS TO THE GROUNDS**

From Interstate 35 N or S: Take Exit 33 at Osceola and turn left (west) onto US Hwy 34. Proceed approximately 13 miles to Thayer. Turn south on county Hwy P-64. Proceed 2 miles to 210<sup>th</sup> St (gravel road). Turn right (west) and go approximately 1-1/4 mile. The field trial grounds will be on your right.

From Interstate 80 W: Take Exit 86 and turn south onto State Hwy 25 to Creston. In Creston, turn left (east) at intersection with US Hwy 34 and proceed approximately 17 miles to Thayer. Follow directions given above.
